Invitation to the dialogue conference: «Development of business models and contracting strategies»

Ruter is set to develop contracting strategies with bus- and boat operators that operationalize its main strategies. These efforts have been organized in the project «Development of business models and contracting strategies» which in October 2015 will deliver a Ruter report on the subject. The main focus in the report will be on bus- and boat contracts, but other contracting areas will also be covered.

Important guidelines for the project:

- A distinct focus on market principles and customer demand. The best interest of public transport customers will form the basis for the project's recommendations
- Evaluating whether the existing allocation of risk and responsibility between Ruter and operators is optimal in supporting Ruter's main strategies.
- Arranging for a sustainable and competitive market for suppliers
- Main recommendations in the report will constitute a key sub strategy for K2016

Ruter will be free to contact the invitees to clarify any questions beyond the agreed meetings if necessary.
